The need for risk governance and leadership arises from the increasing complexity and uncertainty of the business environment. **CERG** is given to high-level ranking officers and decision makers who demonstrate their competency through superior knowledge and experiences in ensuring and overseeing the Enterprise Risk Management implementation in their organization.



**QCRO** is published by LSP MKS for senior management (GM/P) in all

directorates that function as Risk Owner at the strategic level and has the task of ensuring the effectiveness of the risk management process carried out by work units under his coordination, including a member of top management in charge of risk management implementation who acts as a Risk Adviser for members of the organization's top management.



**QRGP** (Qualified Risk Governance Professional) is designed specifically

for professionals who are working at the top management level. In this certification program, skills and knowledge of risk management based on ISO 31000 and corporate governance of these professionals will be measured.
