OVERVIEW



A growing number of organizations from around the world had recognized that the proper management of ESG issues is key to a company's long-term viability. Good ESG practices help a better management of risks to businesses, communities, and the environment, besides also boost their reputation, reduce costs, and strengthen stakeholder relations.

Direct link between ESG practices and financial returns have been proven in several studies. In 2018, while reviewing 656 companies, the International Finance Corporation (IFC) found that companies with good environmental and social performance tended to outperform those with poorer performance on return on equity and return on assets.

This training aims at describing at what is ESG is and why it matters, how companies can implement and integrate ESG in their management while providing examples of good practices, the ESG disclosure, and how to evaluate ESG effectiveness in their organizations.

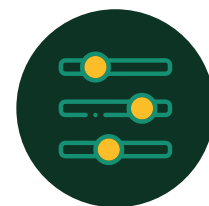
