### Training and Certification

This training approach is a combination of giving presentations by material presenters and class dynamics in the form of discussing case studies of the application of risk management in organizations, application-based simulations, and sharing experiences with practitioners. After attending this training, participants are expected to acquire sufficient knowledge and skills to support the implementation of ISO 31000 as an international standard of risk management which has been adopted as SNI ISO 31000 by the National Standardization Agency (BSN) in their organizations.

- Explaining what risk management is and why it is important
- Simulating an integrated risk management process based on SNI ISO 31000:2018
- Integrating risk management into the organization's business processes
- Gaining insights from the experience of implementing risk management from colleagues

## ISO 31000 GAME-BASED SIMULATION



CRMS Indonesia introduced a new learning method called EMPIRisk Simulation. This learning method is based on a fun simulation game in enabling the participants to apply the materials about ERM that they learn during workshop into a real-world scenario.



A 'game-based simulation' approach will stimulate participants to be able to make risk-based decisions, and also encourage participants to:

- Think creatively in an interactive and fun environment
- Explore and develop during the decision-making process
- Share their experiences with the facilitators who are experts in risk management

# RISK MANAGEMENT PROFESSIONAL CERTIFICATION

After participating in the entire training process, participants can take part in a certification program which is a form of recognition of competence in the implementation of risk management in an organization.

This recognition is beneficial both for someone who is involved in the implementation of ISO 31000 in their own organization or institution, or who has a role as a consultant or independent assessor for ISO 31000.

**QRMO** certification is designed for entry level, fresh graduates, and/or staff in all work units

whose function as beginner Risk Officer beginner and has assignment in supporting risk management process application which is executed by its work units. It also includes the beginner risk management unit staff who acts as risk facilitator for the organization.



**QRMA** is issued by LSP MKS for staff in all work units, supervisory staff, and assistant managers,

who function as middle-level Risk Officers/Risk Champions/Risk Taking Units and are tasked with implementing risk management processes carried out by their work units, including are mid-level Risk Management Unit staff who act as Risk Analysts for the organization.
